<u>Level 2</u>: A Level 2 behavior is one which requires more intensive interventions than a Level 1 behavior, and which may or may not require administrator involvement. Formal documentation should be utilized through site referral procedures (see Referral Form below) and parent/guardian communication is required to ensure students receive the support needed to understand and correct behavior.

<u>Level 3</u>: A Level 3 behavior is one which requires <u>immediate administrative involvement and written</u> <u>documentation in PowerSchool.</u> Level 3 behaviors violate municipal codes and/or laws, are severe, or pose a threat to the physical safety of the individual student and/or others. Written formal documentation describing interventions initiated, conducted or attempted, and parent/guardian communication is required.

Major (Level 3): Behaviors immediately referred to administration (does not always result in suspension) *Any violation on Ed Code 48900 may result in immediate referral to administration Education Code, section 48900	Response to Level 3 Infraction
